This is in response to your inquiry dated <u>October 21, 1991</u> requesting a copy of the letter which granted tax-exempt status to the above named organization.

Our records show that the organization was recognized as tax-exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code and issued a Group Exemption Letter effective January 6, 1950. We have also determined that the organization is not a private foundation because it is described in section(s) $\frac{501(c)(3)\&170(b)(1)(A)(1)}{201(c)(3)\&170(b)(1)(A)(1)}$. Your Group Exemption Number is $\frac{1071}{201}$.

Donors may deduct contributions to you under section 170 of the Code.

You are required to notify the Service at lease 90 days before the end of your annual accounting period, a statement describing any changes during the year in purposes, character, or method of operation of your subordinates.

A copy of our letter certifying the status of the organization is not available, however, this letter may be used to verify your tax-exempt status.

Because this letter could help resolve any questions about your exempt status, it should be kept in your permanent records.

The Internal Revenue Service has determined that the General Conference of Seventh-day Adventists is a 501(c)(3) organization and has listed it in Volume II on page 14 of the most recently published Cumulative List of Organizations described in Section 170(c) of the Internal Revenue Code of 1986 (revised to September 30, 1998). That listing gives the General Conference of Seventh-day Adventists a Code 1 designation, which indicates that it is "(g)enerally, a central organization holding a group exemption letter, whose subordinate units covered by the group exemption are also included as having contributions deductible, even though they are not separately listed." The following secondary schools are covered by the group exemption of the General Conference of Seventh-day Adventists. Gifts and grants to these institutions thus qualify for deductions under Section 170 of the Internal Revenue Code. All are classified as organizations that are not private foundations as defined in 509(a) of the Internal Revenue Code.
